- The marketplace committee will evaluate on an individual basis requests for more than one category in a space.

Booth Display & Sales

- Have fun with your display!
- Keep your display to the size space you signed up for.
- We want each booth to have a unique & attractive boutique look. Be sure to keep stock, boxes and personal items neatly covered and out of view.
- No sales are to be made outside of booth.

Set Up & Tear Down

- Set-up- Starting June 6th, every day from 10-6pm.
- Set-up packets will be available at the office on the event grounds.
- Vehicles must be off showgrounds 1 hour prior to opening time each day, The marketplace will be open to the public Vendors must stay open until closing time each day!
- Take your trash to the dumpster. Trash barrels are not for large boxes, empty containers from set-up or tear down.

Pet, Smoking & Camping

- We do not allow pets on show grounds during marketplace hours. If you are camping on the grounds, it is fine to have your pet with you in your camper.
- Please, no smoking back in the woods.
- We reserve the right to ask anyone to leave that is defacing our property in any way.
- We have primitive camping sites available, free of charge, for our vendors only. Please check with the office for the designated camping and RV parking areas.

Licenses

- Per Ohio law, Vendors are responsible for collecting sales tax and having a valid vendor's license issued by the Ohio Sales Tax Department. Contact for the Ohio Department of Taxation is 888-405-4039.
- Vendors selling food products will need to check in with the Richland County Health Department in order to determine if a license is needed. Their contact number is 419-774-4500. They ask that licenses are obtained no later than 72 hours prior to event.
